The Common Council meeting was called to order by Mayor Shiroda at 5:30 p.m. in the Council Chambers, followed by the Pledge of Allegiance.

MAYOR'S REPORT -

Recognition of Municipal Court Clerk Claudia Last for 14 years of service. Mayor Shiroda thanked Municipal Court Clerk Last for her years of service and presented her with a plaque.

Swearing in of Interim City Attorney Elaine S. Ekes. City Clerk Reynolds swore in Interim City Attorney Ekes. Swearing in of Fire Chief Trent Eichmann. City Clerk Reynolds swore in Fire Chief Eichmann.

Consider Candidates for District I Aldermanic Vacancy. Mayor Shiroda asked both candidates to share why they are interested in the District 1 Aldermanic Vacancy. Karel Young spoke first and Peter Harvey spoke second. Attorney Ekes informed the Council they cannot vote by a secret ballot to fill a vacancy and explained the process to follow for nominations. *Motion (Payson Jr./McClory) to appoint Karel Young to fill the District I Aldermanic vacancy. Roll call vote: Payson Jr., yes; McClory, yes; Harkness, no; Meinel, no. Tie vote 2-2.* Attorney Ekes informed the Mayor and Council she did not believe the Mayor could vote to break the tie. Alderperson McClory questioned why that would be. The Mayor and Attorney Ekes discussed moving the item to later in the meeting so Ekes could research the issue further. *Motion (Payson Jr./McClory) to postpone to later in the agenda and make this item 12e under new business. Voice vote, all approved, motion carried.*

CITY ADMINISTRATOR'S REPORT – Administrator Swann informed the Council the City issued the grading permit for the Creekside Community Development. An amended SIP was submitted by Belinski to modify their plan for the development near Walgreens. The ATV/UTV signs should be installed by the end of the week and the ordinance published this week Thursday. Swann added ATV's/UTV's are not permitted on

County Roads in the city with speed limits greater than 35 mph. Board of Review is Wednesday, May 22nd, the Baby Box has been installed but is not available yet for use, Cobb Rd is now open and Hwy 12 will be closing June 5th in the north part of the city.

Library Board – Library Director Chad Robinson reported completed contracting and zoning of the new sign. EASD appointed a new school liaison and thanked Senta Holmes for her service to the library board. Recreation Advisory Board – Alderperson Payson Jr. reported there may be a meeting in June. Chamber of Commerce – Chris Clapper reported the Spring Food Truck Festival was well attended. Clapper thanked DPW and PD for their help with the event. The new Chamber community guide is out now. Saturdays on the Square begins this weekend and the 50th anniversary is this fall, September 19th. Community Grant Writer – Katie James reported the City did not receive the STP funding grant.

Public Safety - Alderperson Payson Jr. reported on the May 9th meeting regarding personal appearance standards and officer involved shootings and deaths #306.

Police Chief Christensen shared concerns of allowing the extended closing hours and requested the Council ask the City Attorney to draft an ordinance to opt-out. Alderperson Payson Jr. asked Chris Clapper how this will affect tourism in the city during this time. Attorney Ekes explained the legislation and options further. Motion (McClory/Payson Jr.) for the city attorney to draft a proposed ordinance opting out of the state code revision allowing establishments who hold a Class "B", "Class B" or

"Class C" license to offer extended closing hours (between 4:00 a.m. and 6:00 a.m.) for the National Political Convention. Voice vote, 3-yes, 1-no (Payson Jr.), motion carried.

Discussion and possible decision regarding conditional use permit for JRS Holding to operate a transportation facility (in the form of bulk material trucking) at 702 Nathan Lane. *Motion* (Meinel/Harkness) to approve conditional use permit for JRS Holding to operate a transportation facility (in the form of bulk material trucking) at 702 Nathan Lane. Voice vote, all approved, motion carried.

Discussion and possible decision regarding issuing proposed request for proposals (RFP) for needs analysis/study of fire station. *Motion (McClory/Harkness) to approve issuing request for proposals (RFP) for needs analysis/study of fire station. Voice vote, all approved, motion carried.*

Discussion and possible decision regarding recommendations from Human Resources Committee regarding City employee health insurance plan for 2024-2025. Change broker from Rathsack & Associates to Galagher Insurance, Risk Management & Consulting (effective immediately), standardize health reimbursement arrangement for employees so that all employees receive \$500 (as opposed to previous split of \$500 for single employees and \$1,000 for employees with families)(starting January 1, 2025), increase amount employees can contribute to flexible spending account from \$2,200 in 2024 to \$3,200 in 2025 (starting January 1, 2025) and collect monthly premium of 1% of expected plan cost for employees with additional plan participants (i.e., children or spouses)(starting January 1, 2025). *Motion (McClory/Payson Jr.) to approve the items listed. Roll call vote: McClory, yes; Payson Jr., yes; Harkness, yes; Meinel, yes. Motion carried.*

Item postponed from earlier in the meeting: Consider Candidates for District I Aldermanic Vacancy. Attorney Ekes shared information from the State statutes regarding filling vacancies and case law from 1901 explaining when there is clearly a tie the Mayor can break the tie or the governing body can wait and discuss the item at the next meeting. Motion (Meinel/McClory) to appoint a candidate tonight. Voice vote, 3-yes, 1-no (Harkness), motion carried. Motion (Payson Jr./McClory) to appoint Karel Young to fill the District I Aldermanic vacancy. Roll call vote: Payson Jr., yes; McClory, yes; Meinel, no; Harkness, no. Tie vote 2-2. Shiroda, no. Motion fails 2-3. Motion (Meinel/Harkness) to appoint Peter Harvey for District I Aldermanic Vacancy. Roll call vote: Meinel, yes; Harkness, yes; McClory, no; Payson Jr., no. Tie vote 2-2. Shiroda, yes. Motion carried 3-2. Attorney Elaine Elkes swore in Peter Harvey for the District 1 Aldermanic seat.
